Coronavirus? THE CAPITALIST VIRUS IS WORSE!

Johnson's performance after his belated Cobra meeting on Covid-19, was appalling. Predictably, he came out with nothing but platitudes - like urging us to "look out for one another, behave responsibly and think about others"!

His medical advisers did, however, elaborate on his "Action Plan" - which amounts to three things: avoid calling upon the NHS for as long as possible (since it is most likely to collapse otherwise); try to delay the epidemic until the winter rush on the NHS is over (for the same reason); and, above all, ensure that, as much as possible, it's "business as usual"!

Profits come first

So, the 200,000+ visitors to the 4-day Cheltenham festival were given the chance to catch the virus in the packed stands and then pass it on to the rest of us! But then Boris wouldn't upset his peers in the public school and horseracing elite, by cancelling their favourite festival! Never mind if this is totally irresponsible behaviour - once again!

The government's main concern isn't people's health, but the health of capitalist profit. Maintaining "business as usual" won't protect a population threatened by Covid-19, but it is a means to protect the bosses' interests.

So, supermarkets will be able to replenish stocks around-the-clock. But this will also allow retail giants to make a killing out of the stockpiling that the government is officially "discouraging"!

In addition, the government has already announced a series of measures to provide relief to "embattled" bosses.

But Johnson showed no such leniency for workers forced to stay home. He said they should get Statutory Sick Pay (SSP) from day one (instead of day 4) - but that's as far as it goes.



As if anyone could survive on $\pounds 94.25$ /wk! And what about the 6m+ workers who aren't entitled to it? But Johnson, who was until recently paid $\pounds 5,000$ /week by the Daily Telegraph for writing a single article, cannot imagine that such problems exist. He even suggested that self-quarantined workers might apply for Universal Credit... and wait for 5 weeks for it!

Capitalism and coronavirus

By now, the government is faced with an even bigger problem: share prices have fallen at a rate unseen since the 2008 banking crisis. And capitalists are demanding that their respective governments bail them out of this "coronavirus crisis".

Trump has already promised tax cuts for companies and several central banks have made fresh cash available. Johnson is under pressure from the City to do the same.

However it is not, in fact, the coronavirus which caused this meltdown. The financial system was already sick as a dog. Economists had long been warning that share prices were hugely overinflated. As recently as last month, the OECD published an alarming report saying that world indebtedness was way beyond the level seen in 2008.

So this meltdown was a disaster waiting to happen. It was triggered by the coronavirus, but it could have been triggered by many other factors.

In other words, the real cause of this meltdown is the sickness of the capitalist system itself, which has gotten so bad that even the capitalists themselves no longer believe in its health. And since their only aim is to make money, they placed bets that share prices would fall as a consequence of the coronavirus outbreak. Their combined bets have turned into a self-fulfilling prophecy!

We are warned. The coronavirus is a threat that can be tackled, but capitalism is a threat that will only become increasingly dangerous. It is this threat that the working class will need to tackle, by curing society of the sick greed of its capitalist minority and overthrowing their rotten social order.

Johnson watch

Dave was right when he rapped at the Brit awards "our prime minister's a real racist". Yes, Johnson and his ministers are racists, but above all, they are class racists: they only have scorn and hatred for working class people - of any skin colour or nationality.

Take Johnson's sidekick, Priti Patel. She tried (and partly failed) to deport to Jamaica so-called "foreign", so-called "criminals", when in fact they were entitled to British citizenship. Like the Windrush generation, their rights were ignored because they were poor.

A week later, Patel launched an attack against workers of all origins with her draft immigration bill. It will make it more difficult for migrant

Poster kids for racist policies

Proving her devotion to Johnson and his agenda, Priti Patel has devised an immigration points system that would have denied her own parents entry to Britain to live and work! Challenged on this point on Nick Ferrari's LBC show, she made no attempt to deny it. And she is not the only prominent Tory who would not be here under her own preferred system. The parents of Sajid Javid, Suella Braverman, Rishi Sunak and Secretary of State for Business, Alok Sharma, would have found the door closed too! While Patel proudly pulls up the drawbridge that allowed her to grow up in Hertfordshire, Braverman, as attorney general, wants to stop the courts from halting charterflight deportations.

Governed by nationalism, not science!

On the 3rd February, Boris Johnson delivered a speech in which he championed US food. Not only did he ascribe the resistance to chlorinated chicken to "hysteria", but he declared that "The UK will be governed by science not mumbo jumbo..." adding that Americans all looked healthy enough to him! Of course chlorinating chicken isn't the best way to ensure it's free of nasty germs: the wash is applied to the meat's

workers to come and work in Britain - or even retain a job here. But everyone is under threat.

So, for instance, in response to Unison's warning that the new bill would deprive the care industry of the workers it needs, Patel replied that the 8.5m "economically inactive" aged 16-64 will fill these jobs. Never mind that this includes 2.3m students, 2.1m long-term sick, 1.1m in early retirement, and 1.9m looking after their families!

So, is that it? Patel wants more youth, long-term sick and aged workers, to be forced into work? The "hostile environment", Brexit version is coming. And we'll all be legitimate targets this time!

legal right to remain in Britain, has had to apply for this all over again.

In his case the Home Office "app" which was meant to simplify/speed up the application process cocked up. A glitch in its software meant it couldn't recognise triple digit ages and so 100 became 1 and thus 1919 became 2019. The app decided that this

• Patel shows contempt for everyone

At the first Prime Minister's Questions in March, Priti Patel calmly sat at Boris Johnson's right-hand, as he defended her against accusations of bullying her staff. It turned out that this wasn't a one-off with Patel. She had in fact faced similar allegations when she was International Development Secretary, and also when she was at the Department for Work and

surface only, at the end of processing, to save time and money. But neither is the suggested alternative - lactic acid washing - very appetising!

Since Washington's priority in any trade negotiations will be to open the British market for American agriculture, Minette Batters, president of the National Farmers Union (NFU) has been vocal in her opposition: letting in cheaper food, which it would be illegal to produce in Britain, would be "morally bankrupt" and "insane". It's ironic that in 2016 so many of her members voted to leave great-grandfather was a baby of only 1 year and therefore his father's details were needed to verify his right to settlement. Pensions, under Theresa May.

For sure, there are no tears to be shed for the Permanent Secretary she apparently drove out from the Home Office: Sir Philip Rutnam oversaw the Windrush scandal, the hostile environment, and all the other abuses of migrants over the past decade. However, Patel's alleged behaviour is indicative of the kind of people Boris Johnson has surrounded himself with: the most right-wing, socially-repulsive, and incompetent. And of course, Home Secretary Patel continues to charter her planes to send "dangerous foreign criminals back to their native lands", i.e. people guilty of minor offences to places like Jamaica, even if they have never lived there. This is no doubt what makes her popular with the right wing of the Tory party. So she is useful for Johnson to have around, at least for now.

the EU, which so heavily subsidised farmers' incomes! Johnson's proposed "Agricultural Bill 2019-2020" would cut incomes by 25%...

Of course the NFU is protecting its own interests against the threat of American agribusiness giants. But the result of turning food production into a money-spinner - whether in Britain, the EU or the US - is that the rest of us are left with a choice between unhealthy cheap food, and unaffordable healthy food!

Tory hard-right takeover

The Tory hard right is in power. Accusations that the new government is shambolic and run by unelected advisors, or that Johnson is "part-time" (because he avoids public appearances), miss the point. This government, full of contempt and hatred for the working class, is the most right-wing and backward-looking since World War II. And wasn't this what Brexit was always about? The Tories' "hardest" Brexiteers are the same people who have never made any secret of their anti-worker, pro-business agendas.

The likes of Priti Patel and Dominic Raab, in their infamous "Britannia Unchained" pamphlet, claimed British workers are "the worst idlers". They were part of the European Research

• Ministerial zealots

Boris Johnson's latest reshuffle has entrenched this right-wing takeover. Anyone Johnson does not entirely trust to toe the line has gone. That's nearly everyone with enough personal standing or independence to be a rival, except Michael Gove.

Others who stayed include Matt Hancock, probably the only person who was prepared to be Health Secretary despite the crumbling state of the NHS, and Priti Patel. Even Sajid Javid resigned as Chancellor, rather than become a prisoner of No 10, by letting all his own advisors be sacked on Johnson's orders.

Right-wingers like Andrea Leadsom, Theresa Villiers and Esther McVey showed no signs of disagreeing with Johnson, but were all senior enough to do so, one day or another - so out they went!

• Dullness is preferred

Why sack Julian Smith as Northern Ireland Secretary after he restored the powersharing government suspended for the previous three years? Probably because that made Smith too successful for Johnson's liking, especially as Smith had no noticeable support from Johnson in this initiative.

It also made Smith far too popular both sides of the Irish border. Smith's conciliatory noises to those seeking reparations for British army violence during the Troubles were already provoking a backlash from xenophobic backbenchers like Mark François, a former soldier and a staunch Johnsonite.

New passport: blue... like the EU

There's been much hype and nonsense around the issuing of the new, post-Brexit, blue passport. As if Britain's departure from the EU depended on it. So we're told that the change from the EU's burgundy colour and the fact that the words "European Union" will no longer

Smith's replacement, Brandon Lewis, a former Tory chairman and immigration minister, can be relied upon to trot out any government line and probably to do the bare minimum in Northern Ireland, just like Smith's predecessor, Karen Bradley.

Sunak's meteoric rise

Javid's replacement is Rishi Sunak, the 39 year-old former chief secretary to the Treasury who has only been an MP since 2015. This former City investment banker and hedge-fund manager is estimated to be the richest MP, having married into India's sixth richest family - which co-owns the multinational company, Infosys.

Johnson had already groomed him for promotion by getting him to take his place in two of the televised election debates. Then he brought Sunak into Javid's Treasury and has now promoted him again. Sunak will be on a tight leash. He may have impressed in the City, but there's no shortage of ex-fund managers on the Tory backbenches!

• Will Braverman brave the law for Johnson?

Suella Braverman, the new Attorney General, replaces Geoffrey Cox, whose advice that proroguing parliament was legal was overruled in the Supreme Court. Undeterred, Braverman promises to "take back control" for the benefit of Johnson. In other words, she expresses King Boris's frustration that his follies were blocked by the courts, or found illegal by judicial review.

Braverman is a barrister and also a former chair of the hard-Brexiteers' ERG.

• Green light for the Tory right

The Tory party's right-wing, far from quietening down after the election, has resumed loud posturing. Leading right-wing Tories, including former party leader Iain Duncan-Smith and David Davis, ex-Brexit Secretary, began by attacking Johnson's decision to allow Chinese company Huawei to develop Britain's 5G network. Never mind that Huawei is to provide only 35% of the new technology, and that it's been involved with companies like BT for over 15 years! Meanwhile, the Home Secretary has been playing to anti-immigrant bigotry by proceeding with her Windrush Mark 2 deportations to Jamaica.

But since Johnson owes his position to the support of this right-wing, he is obliged to appease it. So a no-deal Brexit is back on the table, despite his having previously ruled it out. He has also questioned any alignment with EU labour and environment rules. despite agreeing this in the Withdrawal Bill just a few months ago! Indeed, in his recent reshuffle, the only qualification for some posts appeared to be Brexiteer bravado - like, for instance, David Frost, outspoken Brexiteer and former CEO of the Scottish Whisky Association, who is now Chief Negotiator with the EU! Yes, Johnson continues to play to this dinosaurs' gallery, but is completely blind as to where it might lead him... back to that ditch?

queue at the EU border, with all the other "Non-EU" passport holders, instead of walking straight through? All worth it, surely, if "Great Britishness" can reassert itself! The combined force of storms Ciara, Dennis and Jorge flooded an estimated 3,300 properties. Ten of thousands were left without power. Existing flood defences were breached. Farms, roads and railway lines were covered with water. And what did the government do? It congratulated itself for its "timely" and "proportional" response!

Environment Secretary, George Eustice, and PM Johnson (when he could be found!) told journalists repeatedly what huge sums of money (billions!) the government had pumped into "flood defences" - without specifying exactly when or where - thus "protecting" thousands of homes which would otherwise have been flooded. In other words, their answer to the many flood victims was, "trust us, it could have been so much worse!" But if they were so "up to speed", why did they avoid visiting affected communities? Eustice claimed it wasn't necessary, since "we've had a

grip of this situation". When in fact the "situation" mostly got out of hand!

Environmental experts say current flood defences are inadequate. They are certainly not fit for the worse floods to come. But despite this, 20% of planned new builds in just-flooded Midland towns will be built on flood-risk land. Developers claim there isn't "enough" land available for house-building. But that's only because the current system of private landownership means that vast tracts of land are are inaccessible. If land was nationalised, and owned by the population collectively, then planning would be a doddle - and nobody would have to worry about flood-water pouring in their front doors, ever again.

Rough sleeping

In the past five years, at least 7 rough sleepers have been crushed to death in waste compactor trucks. Yes, rough sleepers are driven by the rain and cold - and the lack of adequate alternatives - to sleep inside bins!

But these shocking deaths are only the tip of the iceberg. A study by the King's Fund shows that the average age of death for those who died while homeless in England and Wales in 2018, was 44 - more than 30 years less than the population as a whole! But these figures still underestimate the

of self-employed people are not counted at all. So, given that "a record" 5 million people (up from 3.8 million in 2008) are "self-employed" (which usually means they are subcontracted by agencies), this means that the earnings of 15% of the workforce is not included in this "average"!

magnitude of the problem: many deaths are not even recorded as being linked to homelessness, due to uncertainties over the place of death and incomplete investigations. The truth is that the combination of destitution and cold/wet weather is deadly!

Nevertheless, to date, the government still refuses to collect precise data on rough sleeping. So, while official statistics claim that rough sleeping went down by 9%, to 4,266, last year, the figures collated by local councils show a total of 28,000 roughsleepers for last year. Over 6 times what the government claims!

show what's really going on!

But never fear: after a pleasant break in his 115-room Chevening mansion in Kent, Johnson appeared at a homelessness charity in London, claiming he would "*end rough sleeping once and for all*", by 2024. This is the same Johnson who promised, when he was Mayor of London, to end rough sleeping in the capital by 2012 - but the number actually doubled under his watch! In the meantime, there are 634,453 empty homes in England alone. Enough to solve rough sleeping and homelessness straight away!

Newham's rough sleeper-cleansing

tents used to stand, to keep the homeless away.

The Mall is a "public right of way" through to the station, Olympic Park and Westfield shopping centre, so its doors can't be locked. Shopkeepers constantly complained about rough sleepers on the floor inside and in tents outside. So they have been "cleansed". But as Hope4Newham charity wrote, "Yes the council got rid of their tents and some have been put up in the [25-bed temporary homeless] hub but there are still many sleeping rough in Stratford centre. There are posts going around saying how the homelessness has gone down around that area but unfortunately it doesn't reflect ...how many we are still serving [in their soup kitchen] on a Tuesday evening".

The fact is that 1 in 25 people in Newham are homeless - the highest number in Britain. There are over 27,000 on the council waiting list and over 5,000 in temporary accommodation. Rough sleeping has tripled since 2010. Newham's mayor, Rokhsana Fiaz, pledged to address these problems and is at pains to prove she has done so, now that she's campaigning for re-election. But all she's done is push the homeless out of sight. Until they return.

Coronavirus

Since new coronavirus (Covid-19) Started to spread in China and beyond, its impact has been causing great anxiety in business circles.

Over the past two decades, most western multinationals re-organised their production on a world scale. To maximise their profits, they sought to take advantage of the low labour costs in poor countries like China and of their largely untapped domestic markets. So, now, they have a problem. Not that they give a damn about the human cost of the pandemic. No, they are worried that the lock-down of large areas in China may disrupt their supply chains across the world and dent

Can the NHS cope?

So is the NHS ready, as the government claims, to deal with Covid-19? We're told that Public Health England (PHE) is fully prepared... Well, it can, in theory, carry out accurate tests for the virus. And this is entirely due to the swift sharing by Chinese microbiologists of the Covid-19 gene sequence. But whether PHE has enough test kits remains to be seen. So far, several people who've duly notified NHS 111 emergency helpline to say that they've had exposure to contacts or have 'flu-like symptoms, have been kept waiting at home, without hearing a thing, for up to 5 days. And then there's the waiting time on the phone line 111, which is reported to be several hours to 3 days despite recruitment of additional staff...

Belated action plan

It was only on the 3rd March that the government published its "Action Plan" - over a month after the first positive diagnosis of the virus was confirmed. By 9 March, there'd been 5 deaths out of 319 people who'd tested positive, scattered all over the country, so in reality, the virus is set to break out everywhere. And hand-washing obviously won't stop it, since it's mainly transmitted through breathing in virus droplets in the air. So unless *everyone* stays at home and public

The Marmot review: austerity kills

The review entitled "Health Equity in England" by Michael Marmot, Professor of Epidemiology at University College London, is crystal clear in its conclusions. Austerity kills. This review is a follow-up to a report he did 10 years ago, before the Tory-LibDem coalition's drastic cuts to the public sector and local authority budgets and before the roll-out of Universal Credit. In 2010 it was still possible to say that the trend for life expectancy was generally upward.

Not so today. For the first time in

their profits!

Other companies have similar worries, albeit for different reasons - oil giants, airlines, tour operators, etc... This is what economists and big business have been warning against, over the past few weeks. And this is what speculators are anticipating, judging from the sharp fall that took place since mid-February, on the largest stock markets.

Besides, the impact of Covid-19 in rich countries like Britain, may also hit their profits. And this is what will determine the choices made by governments in their fight against the coronavirus. In so far as their capitalist masters may face significant losses should the pandemic get out of hand, governments will put the necessary resources into fighting it. But in the process, they will leave the profit virus - i.e. the bosses' greed - free to take its toll on the working class and society.

So, while Covid-19 itself will eventually cease to be a danger, the profit virus will remain as a permanent threat. There is, therefore, every reason for the working class to be vigilant and to prevent the bosses and their trustees in government to use the cover of Covid-19 as a justification to inject an even larger dose of this profit virus into society!



transport is totally closed down (one of the main "large public gatherings" we participate in every day) the incidence is bound to grow in leaps and bounds.

No beds

So what about NHS facilities? It's all very well to talk about mobilising retired staff or medical students, but there were already 100,000 unfilled vacancies before Covid-19. Hospitals are operating at full capacity; there are no excess social care beds to discharge patients to. And what really counts in Covid-19 pneumonia is

100 years life expectancy is falling in large parts of the country. This is the case for men in the most deprived 10% of neighbourhoods in the North East, Yorkshire, Humber and the East of England. But for the 10% poorest women, it is decreasing in every single region except London, parts of the West Midlands and the North West. So men in these deprived regions can expect to live to 73.9 years compared to 83.4 years in the richer regions - 10 years less, while the lifespan for women in the North East is 78.7 years compared to their richer counterparts who'll live on average to 86.3 years -a difference of 7.6 years.

having acute respiratory intensive care, oxygen and respirators. Yet Britain has the fewest intensive care beds out of all OECD countries, just 4,000 (Germany has 16,000!) with four-fifths occupied. The government claims that if more beds are needed the NHS can "cut back" on procedures/treatments and make choices about who to keep alive! It already has to do that. In fact if just 1% (best case scenario) get the virus, that could mean 70,000 needing intensive care. The consequences of this don't have to be spelt out.

The report shows that the cuts in people's incomes over the past 10 years directly corresponds to the deterioration in their health. Says Marmot: *"This damage to the nation's health need not have happened. It is shocking. (...) Poverty has a grip on our nation's health - it limits the options families have available to live a healthy life... Something has gone badly wrong."* While it's no great discovery that poverty causes illhealth and that it even kills, it's no bad thing that Marmot has highlighted this once more - and explicitly condemned government policy! 65

Letter from India

As Trump was visiting India's prime Minister, Narendra Modi, in the last week of February, the capital city Delhi saw one of the most brutal outbreaks of anti-Muslim communal violence in recent decades.

Several poor districts of North-East Delhi were ravaged. Hundreds of houses were burnt down, together with shops, workshops and 4 mosques. In the process, tens of thousands fled the area and are too scared to come back. An estimated 53 people have been killed and over 200 sustained serious injuries from gunshots, sharp-edged weapons and stone-pelting - although the real number of casualties is certainly higher.

These pogroms started after Kapil Mishra, a local leader of Modi's ruling Hindu nationalist party, the BJP, gave the Delhi police an ultimatum to remove a protest sit-in against the Citizenship Amendment Act - part of Modi's plan to deprive Muslims of their rights.

In fact, by that time, 2,000 thugs had been brought into the area by militant groups connected to the BJP. These thugs were heavily armed, with petrol bombs, iron rods and guns. After Mishra's ultimatum, they went on the rampage against neighbourhoods where Muslims live in large numbers. As to the Delhi police, which is directly under the

Asia Bibi

Asia Bibi, who spent 8 years on death row after she was accused under Pakistan's notorious blasphemy law of defiling a water-cup used by Muslim fellow farm workers, is now being permitted to apply for permanent asylum in France.

This comes 2 years after her hardfought reprieve in Pakistan. Thereafter she and her family had to go into hiding. They were subject to death threats from vicious hard-line supporters of Thereek-e-Labbaik

British Museum to lose its marbles - at last?

Now that Britain is exiting Europe, will the British Museum's Parthenon Marbles (aka the "Elgin Marbles") finally be returned to Athens? They were part of the 160-metre frieze adorning the 5th century BC Parthenon temple in Athens, and were systematically hacked off and removed by Lord Elgin in 1802, to decorate his stately home in Scotland. He finally sold them to the British government in 1816, to settle

authority of Modi's government, it looked on and, sometimes, even joined the pogromists.

After two and-a-half days of these pogroms, Modi finally issued this statement: "I appeal to my sisters and brothers of Delhi to maintain peace and brotherhood at all times". This was a signal to his party's thugs that the bloodshed had gone on for long enough, for the time being, anyway. And the attacks stopped.

That Modi should have chosen this particular time to engineer such a bloody pogrom was not a coincidence. He had been indulging Trump with enormous, rapturous audiences - far larger than Trump could ever manage to attract in the US. He certainly hoped that Trump would see his regime as a "special" future trade partner and a counterweight to China. But, above all, Modi was desperate to prove that he could be a regional pillar for Trump's crusade against what he calls the "Muslim threat". By unleashing terror against a Muslim neighbourhood in the capital and stopping it at will, Modi had demonstrated in practice what tight control he had over India's huge Muslim minority and, more generally, his ability to crush domestic dissent. In short, that he was a leader to Trump's liking!

Another of Britain's refused asylum seekers

Pakistan a far-right Islamist political party, already linked to the murder of 2 wellknown politicians who'd supported her case.

At the time, Asia requested urgent asylum, but Britain was one of the first to refuse: then Prime Minister Theresa May said it might stir unrest *"among certain sections of the population"*. Not that she didn't face criticism for pandering to religious bigots, even from members of her own party.

debts. Since then, the Parthenon Marbles (and others he looted) have been in the British Museum, together with thousands of stolen antiquities from around the world.

Greece has been demanding their return since 1832, when it first began to restore its ancient monuments. But the British government has always refused, despite the unarguable case against it. In fact the Acropolis Museum in Athens has custom-made spaces for the missing pieces, in order to complete the restoration of this magnificent frieze. To this end, Greece, Cyprus and Italy included Asia eventually got one year's refuge in Canada. She hasn't decided whether to move to France yet, but would ideally like to go back to Pakistan - when it's safe to do so. However, in the context of a capitalist system rotting on its feet, when political rulers are busy scraping the bottom of a barrel crammed with bigotry, nationalism and class hatred, "safe" places will only come into being if there's complete system change.

a clause in the EU trade negotiations with Britain that would require the "return or restitution of unlawfully removed cultural objects to their countries of origin".
